1. Decentralization in Institutional Governance

- The organogram indicates the decentralised functioning of the college.

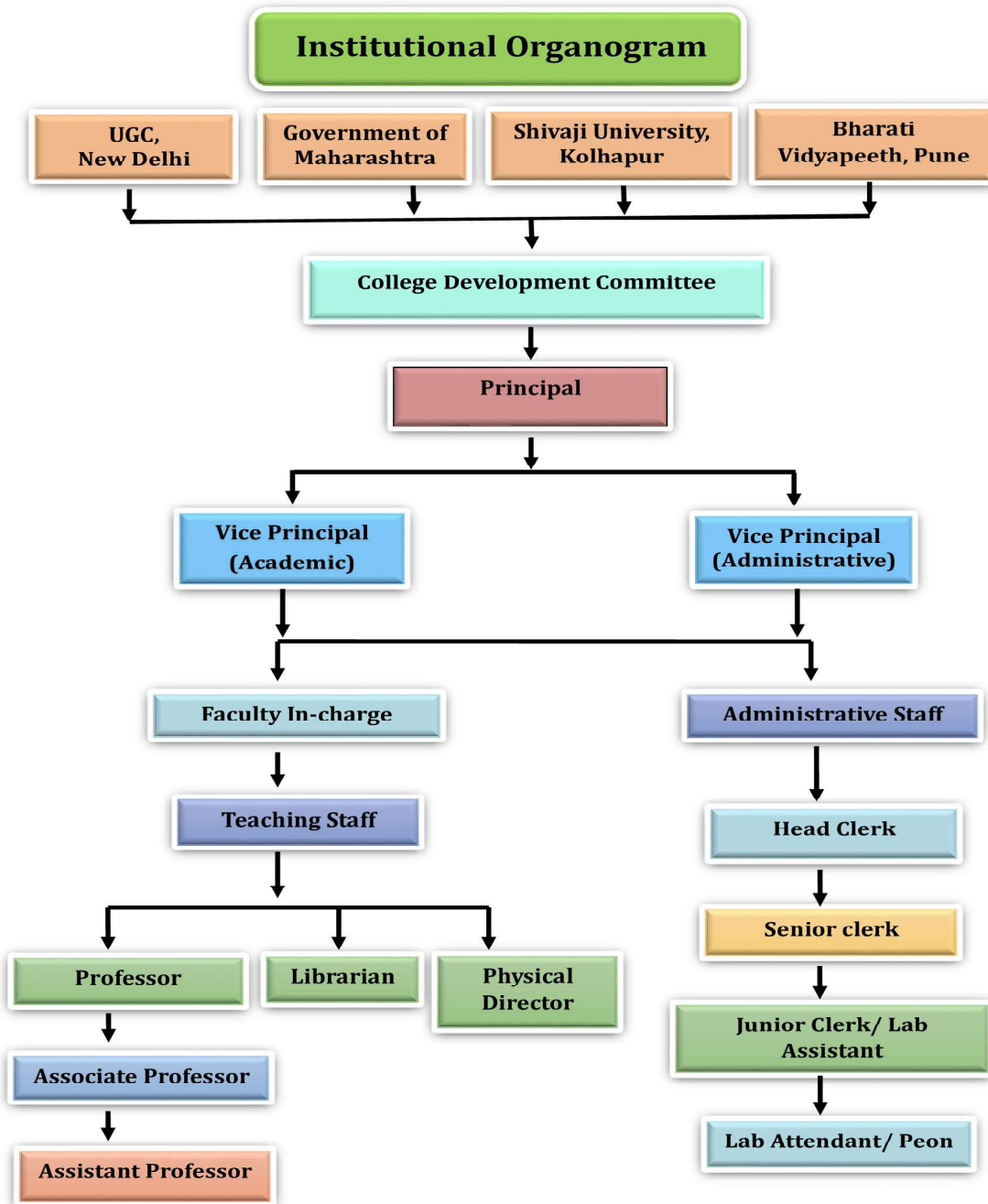
