Purpose/Objective:

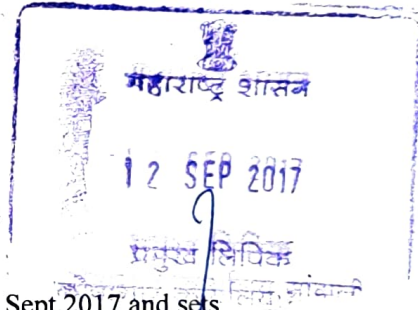
- i) To promote and enhance linkages between party one and party 2.


