1. Objectives of the MoU

The objectives of the MoU are:

- a) To promote and enhance academic interest between **Bharati Vidyapeeth's Dr. Patangrao Kadam Mahavidyalaya, Sangli** and **Karmaveer Bhaurao Patil Mahavidyalaya, Pandharpur**.
- b) To share expertise for implementation of quality of education in both institutions.
- c) To encourage and provide information to bright students of both institutions to progress for post-graduation at University/Research Institute/Organization etc.
- d) To promote interdisciplinary research activities between both institutions.
- e) Exchange of faculty, students and scholars of both institutions.

2. Technical Areas of Collaboration

- a) Quality improvement through faculty developmental programmes.
- b) Provide academic interaction
- c) Necessary help in organizing workshops/conferences/seminars etc.
- d) Necessary support for designing of curriculum.

3. Proposed Mode of Collaboration

Dr. Patangrao Kadam Mahavidyalaya, Sangli and Karmaveer Bhaurao Patil Mahavidyalaya, Pandharpur propose to collaborate through the following:

- a) Cooperation and promotion of research in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between both the institutions.

4. Terms and Conditions:

- a) In order to carry out the above mentioned activities, detailed plans of the academic cooperation, strategies for the interactions and mechanisms leading to the exchange of faculty and students shall be formed through consultation between two institutions and expressed in academic agreements.
- b) This MoU may be amended, renewed and terminated by mutual written agreement of both the parties at any time.

5. Confidentiality:

- a) Dr. Patangrao Kadam Mahavidyalaya, Sangli and Karmaveer Bhaurao Patil Mahavidyalaya, Pandharpur agree to hold all information/data designated by the institute as being confidential which is obtained from either institute or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other institute.

6. Duration of MoU

This MoU, unless extended by mutual written consent of the institute, shall expire in 5 years after the effective date.
