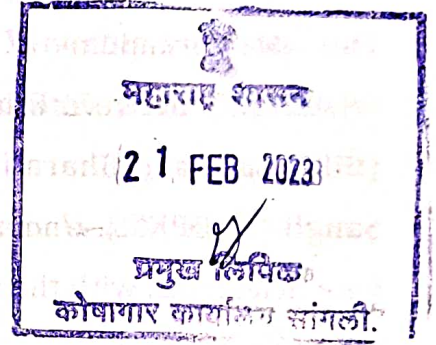

**PURPOSE:**




